Tuition is considered delinquent if not received by noon on the following Monday. Delinquent payments will be assessed a late fee of \$15.00 per day. If payment is not received by Wednesday, CCC reserves the right to suspend attendance. A \$25.00 fee shall be charged for any check returned from the bank. Written notice of tuition rate changes will be made at least 30 calendar days in advance by CCC. Parent(s) or guardian(s) who receive subsidized child care, have read and agree to the policies center provided. Intials

Credit will not be given when the center is closed for holidays, absences of Child including days missed due to illness, or vacation days taken in excess of (see our parent handbook at www.columbiachildrenscenter.com). Refunds of unused tuition and fees shall be given only upon at least two weeks' notice of withdrawal from the program. Parent(s) or guardian(s) shall give the Director at least two weeks notice of vacations or changes in schedule. Intials												
19.	Parent(s) or guardian(s) agree to pick up Child from CCC no later than the contracted hours. Children picked up after 5:30 p.m. will be charged a late fee of \$15.00 per each 15 minutes. For example: 5:31 to 5:45 = \$15.00, 5:46 to 6:00 = \$30.00.
